Electricité du Cambodge (EDC) has the honor to inform the public that under the highest consideration of improving the level of living condition of the population in rural area, the Royal Government of Cambodia (RGC) under the leadership of **Samdech Akka Moha Sena Padei Techo Hun Sen, Prime Minister of the Kingdom of Cambodia**, has issued "Strategic Planning for Reduction of Tariff for Sale of Electricity in the Kingdom of Cambodia by reimbursing the gap between actual cost and the tariff for sale of electricity". To implement this strategic planning, Department of Rural Electrification Fund of EDC (hereinafter referred to as the "REF") is in charge of reimbursing the gap between actual cost and the tariff for sale of electricity for use by the rural households and use for irrigation from 9:00 p.m. to 7:00 a.m. as a subsidy to the licensees.

To implement this Strategic Planning in a transparent manner without discrimination, REF requests the electricity suppliers to cooperate and act in a highly responsible manner and provide data on the quantity of the energy used by the rural households and for irrigation accurately and properly including the related documents, to REF for review and release of the subsidy payment under this Strategic Planning on time.

This Strategic Planning is on-going program from 2016 and will also be implemented in 2021.

Electricité du Cambodge (EDC) has the honor to inform the public that in accordance with the Policies for Electricity Sector of the Royal Government of Cambodia (RGC) formed in accordance with the Sixth Mandate of the National Assembly, RGC has the ambition to manage and strengthen the development of electricity sector in order to "reach and achieve sufficient, sustainable, reliable, quality and affordable electricity supply for all categories of consumers throughout the Kingdom of Cambodia". EDC has continuously provided grant to the Department of Rural Electrification Fund of EDC (hereinafter referred to as the "REF") in order to implement the program "**Providing Electricity for Pumping for Agricultural Irrigation Uses**". This program is on-going program from 2016 and will also be implemented in 2021. The purpose of this program is to facilitate construction of the infrastructure to provide access to electricity from the grid system for agricultural irrigation uses at concessional rate of 480 riels per kWh for use during night time from 9:00 p.m. to 7:00 a.m. and normal rate per kWh for use during day time from 7:00 a.m. to 9:00 p.m. The assistance to be provided by REF will include construction of the infrastructure, the prepaid TOU or EDM meter, blank prepaid cards, refill machine to charge the prepayment card. REF will construct the required infrastructure (MV line, MV/LV transformer, LV line and the accessories) through contractors appointed by REF and handover the infrastructure and meter etc. to the licensee.

To implement this Program in a transparent manner without discrimination, REF requests the electricity suppliers, the concerned ministries, consumer to cooperate and act in a highly responsible manner and provide the required information to implement this program to REF.
